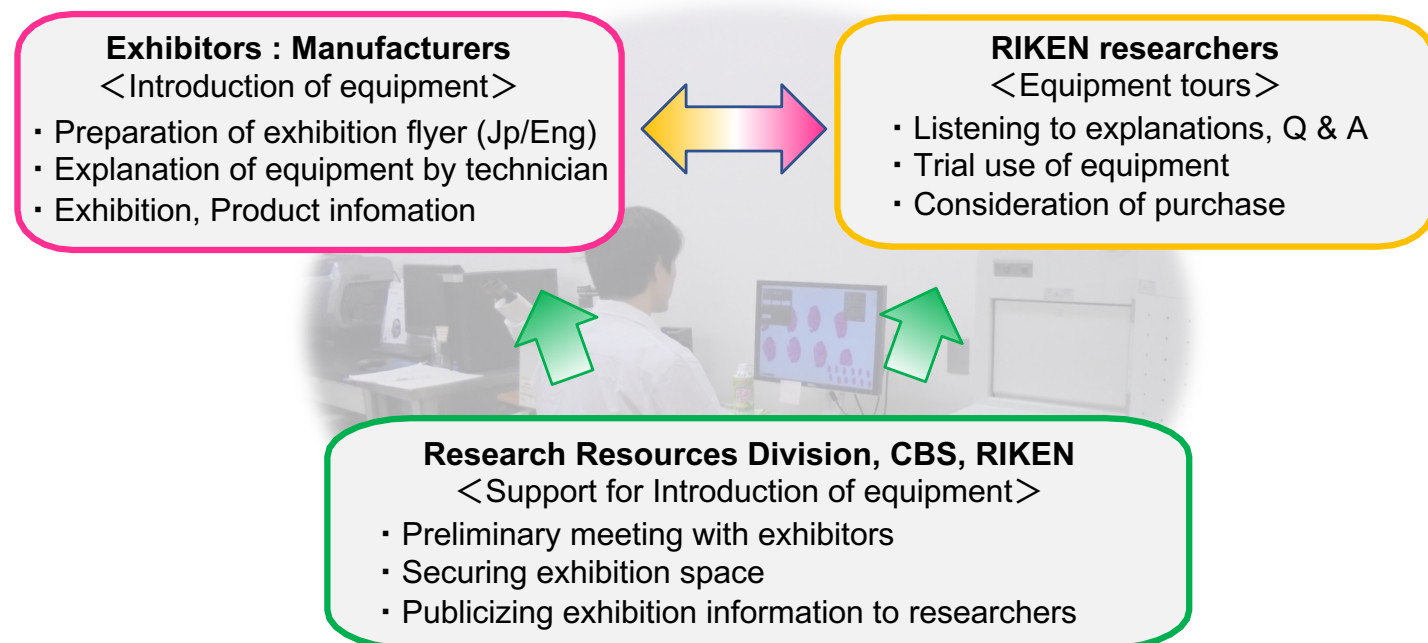


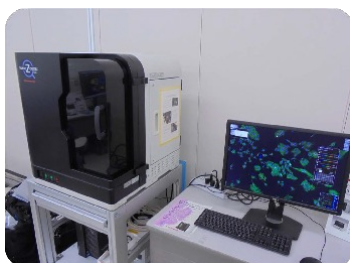
## Would you like to exhibit your research equipment and materials at RIKEN Center for Brain Science?

- Exhibition requirements
- ☑ Exhibitor: In principle, conducted by equipment manufacturers
  - ☑ Venue: C109-1, Brain Science Central Bldg, CBS Wako RIKEN
  - ☑ Exhibits: Mainly for neuroscience
  - ☑ Exhibition duration: 1 day to 1 week
  - ☑ Exhibition style: Hybrid events both online & onsite
  - ☑ Briefing: 30 minutes in Japanese and English online or onsite

## Support for spread of technology RRD Exhibition for Research Materials

In order for researchers to make informed decisions about purchase of newly developed research equipment and materials, we have been introducing a forum for exhibiting products on a fair and equal basis. The exhibitions are based on the following guidelines.

### Note

1. **Exhibitors:** The exhibitions are given by manufactures directly, with not intermediaries.
2. **Exhibition products:** Specific equipment and materials for neuroscience.
3. **Who may attend:** All CBS and RIKEN members.
4. **Application procedure:**  
Preliminary meeting: Contact the RRD representative by e-mail at least 6 weeks prior to the desired exhibition date. We will arrange a date for a preliminary meeting.  
↓  
Application form: RRD will send you an application form and instructions.  
↓  
Selection of products: RRD consults with specialists (researchers) to determine the suitability.  
↓  
Exhibit dates to be decided.
5. **Exhibition style:** Hybrid events both online & onsite.
6. **Exhibition hours:** 9:00 - 17:20 during RIKEN working hours (for exhibitors who bring their own equipment, including carry-in and carry-out).
7. **Exhibition method:** Please hold a 30-minute product information including a Q&A session by the engineer. Please use both English and Japanese.  
It would be effective to attract visitors if you allow trial use of the equipment during the exhibition period.
8. **Exhibition fee:** Free of charge. However, expenses for carrying in/out, setup, maintenance, removal, etc. as well as consumables for trial use must be paid by the exhibitor.
9. **Storage of exhibit materials:** Exhibitors are responsible for the storage and management of their exhibit materials during the exhibition period. However, RRD is responsible for unlocking and locking the room.
10. **Consultation on necessary matters:** In addition to the above, any other necessary matters that may arise are agreed upon by both parties.
